#### **Elections 2007**

As you may recall, at the end of last year, we asked you to consider revising the Chapter bylaws. The voting members unanimously approved the revisions.

The main purpose of the revision was to provide more flexibility in electing officers and encourage participation on the Executive Board. In summary, candidates can now be elected to the Board in a general election. The Board members will then decide who will fulfill the specific roles, depending on the number of Board members. To encourage participation, up to 7 Board members can be elected. A minimum of 3 Board members, fulfilling the role of President, Vice President, and Secretary/Treasurer, is required. If there are more positions than candidates (or if there are an equal number), elections are considered uncontested and the Board will ask the membership to ratify the election by announcing it in the Magpie (as we are here).

In 2007 we had fewer people agree to run for a Board Member position than open positions. Kirsten Christopherson, Melinda Dorin, and Sara Lee are planning to continue on the Board. Natalie Cull and I regret that we need to take some time off, as we are both expecting our 2nd children and anticipate that we won't have sufficient time (or energy!) to devote to Board activities in the coming months. We are excited to welcome the participation of Hal Holland and Armand Gonzales as our newest Board members. If you have concerns about any of the proposed Board Members, please let me know.

# Willow Flycatcher Workshop: Identifying Habitat and Implementing Surveys



Sponsored by the Sacramento-Shasta Chapter of The Wildlife Society.

**Date:** To be determined, but sometime at the end of **June 2007.** 

This workshop will focus on identifying willow flycatcher habitat in the Shasta-Cascade and northern Sierra Nevada regions of California. This 1 and ½ day workshop will be geared towards natural resource planners, foresters, biologists, and others who are responsible for identifying habitat on the ground and conducting surveys within suitable habitat related to land management activities.

The first day of the workshop will cover basic identification (visual and vocal), status, pertinent regulations, willow flycatcher DFG habitat model development and recent updates, identifying habitat (including marginal habitat) and finally survey design and layout for the field portion of the workshop the following day.

The second day would be a complete field day, starting at dawn with our survey for willow flycatchers. We will work in small groups to complete the surveys and each crew will be responsible for their own survey transect. We will regroup and discuss the outcome of the survey and any questions or concerns with the survey protocol. We will wrap up the workshop by looking at marginal habitat in comparison to potential habitat at a couple of different sites along the McCloud River.

Creek Week Birds and Blooms Tour Saturday, April 21 1:30 pm - 3:30 pm

The Fishhead Lake mitigation wetland is a nice example of wetlands created as mitigation for earlier wetland losses. The wetland has both a permanent and seasonal component as well as a surrounding upland buffer. Thousands of waterfowl winter at the wetland and many remain year-round to nest and raise young. Much of the area is planted to native wildflowers that bloom in early spring. California poppies, lupines, owl's clover, baby blue-eyes, and many others can bee seen spreading about the uplands and wetland edges. Visitors will receive a packet of native flower seeds to start their own native garden.

Creek Week- Local Fish Fauna Wednesday, April 25 12:00-2:00 PM

What lurks in the murky depths of Sacramento's urban Join SRCSD Bufferlands creeks? staff for an introduction to the local fish fauna. We will demonstrate fish sampling techniques in a local lake, practice hands-on (for those that aren't too squeamish) fish identification, and discuss the natural history of California's diverse fish communities. In addition, we will be able to view one of the direct consumers of the local fish populations as we spy on a large heron and egret rookery. This tour includes a short, 1/2 mile walk and an opportunity to see some of the Bufferlands riparian and wetland habitat restoration projects

Spring Migration at the Bufferlands Saturday, April 28 7am - 11:30 am

This morning tour of the Bufferlands will focus on finding migrant songbirds, resident breeders, and lingering winter residents. The heron, egret and cormorant rookery will be in full swing, and if water levels are right, we could have excellent shorebirding conditions. The Bufferlands contain 2,650 acres of wetlands, riparian forest, grasslands, vernal pools, and restored habitats. Be prepared for potentially muddy trails and up to 3 miles of walking.

Walk on the Wildside - Rookery Tour Saturday, May 12 10:00 am - 4:00 pm

Join the Sacramento Regional County Sanitation District (SRCSD) Bufferlands and the Stone Lakes National Wildlife Refuge for a Walk on the Wildside, a celebration of International Migratory Bird Day. Walk on the Wildside highlights local efforts to protect and restore Central Valley habitats. This free, family-oriented event includes tours, presentations, live animals, music, hands-on activities, informational exhibits, and more. Guided and self-guided tours are offered throughout the day. Explore a pristine valley oak riparian forest in search of migratory songbirds. Visit numerous wetland and riparian restoration projects. Enjoy a unique opportunity to see one of approximately four heron rookeries Sacramento County on a Bufferlands guided tour. This rookery contains over 100 active nests of great blue herons, great egrets, and double crested cormorants. Spotting scopes will be available for optimum viewing of these fascinating and beautiful birds.

## Sacramento Area Flood Control Agency (SAFCA): Natural Resources Intern

<u>Job Description</u>: SAFCA is responsible for several bank protection and mitigation sites along the Lower American River and in North Sacramento. The basic duties of the Natural Resources Intern will include identifying plants by species, measuring plants and recording data, marking counted plants, data entry, analysis and reporting. Assistance with pre-construction surveys for various flora

and fauna will be on an as needed basis. The Intern will also assist the SAFCA Natural Resources Team with clerical and administrative functions that includes attending meetings, preparing meeting notifications, maintaining working group binders, contacting committee members and arranging meeting venues. Assistance will also be needed from time to time with routine office duties such as copying, filing, mailing documents and other tasks as needed (occasional pickup & delivery of documents).
